Subject: - Instruction regarding proper channel for representations / communications to be made by Government servants of their service matters and other issues - reg.

In their OM No. 35-04/2015- O&M/PG dated 28.08.2015, the ministry has referred to the Cabinet Secretary's D.O. No. 501/1/4/2014-CA.V dated 17.08.2015 addressed to the Secretary, Department of Agriculture & Cooperation, New Delhi, which, inter alia, observes the following:-

"Of late, it has been observed that Government servants are addressing communications on service matters and other issues directly to the Prime Minister/Prime Minister's Office, which is a violation of Conduct Rules."

The above referred D.O. letter further says that "Instructions have been issued time and again regarding the proper channel for representations/communications to be made by Government servants on their matters and other issues. As per these instructions, whenever, in any matter connected with his service right of conditions, a Government servant wishes to press a claim or to seek redressal of a grievance, the proper course for him is to address his immediate official superior, or Head of this office, or such other authority at the appropriate level as is competent to deal with the matter in the organization. Adequate instructions are also available in the matter of submission of representation by Government servants and disposal of representations by the authorities concerned. As such, submission of representations directly to higher authorities by-passing to prescribed channel of communication is a violation of Conduct Rules and has to be viewed seriously."

It is also mentioned in the above referred D.O. letter to "reiterate the instructions on the subject for strict compliance and appropriate action may be taken against those violate such instructions."

It is therefore, all the instructions are hereby brought to the notice of all officers/officials and advised them to affix their signature in the token of having seen the above instructions against their name contained in Annexure.
