- Av. number of plants per hill was recorded as 4 to 5.
- Av. spacing between hills was recorded as 15.7 to 16.0 cm.
- Av. total number of hills in 5 m row length was recorded as 24.
- Av. number of hills per sq. m. was recorded as 24.
- Av. percentage of missed hills was recorded as nil to 0.83.
- Av. percentage of floating seedlings was recorded as nil to 0.83.
- Av. percentage of buried seedlings were recorded as Nil to 0.83.
- Av. percentage of damaged seedling were recorded as nil to 0.83.
- The total percentage of transplanting faults was recorded as 0.33 to 1.66.
- The consumption of nursery trays was recorded as 185 to 207 numbers per hectare.
- The hourly fuel consumption was recorded as 2.10 to 2.24 l/h and fuel required for planting of one hectare area was recorded as 6.51 to 7.66.
- **17.2.1** The quality of work was observed as smooth during entire transplanting operation. The overall performance of the machine was found satisfactory.

17.3 Components/assembly inspection

- **17.3.1** The transplanter and engine were dismantled after 40.91 hours of operation and wear of critical components were observed within the limits.
- 17.3.2 The main gear box, planting box, planting arm drive mechanism and bearings were dismantled after completion of field operation and found in satisfactory working condition and further also found that there is no ingress of water and/or mud against the sealings provided.

17.4 Safety provisions

The machine is provided with various safety provisions while working in the field or moving on the road as mentioned in the **clause 5.12** of this test report.
