- 12.1 Dimensional requirements of single axle (semitrailer) Conforms to IS 8213:2020.
- 12.2 To protect from mud and soil the rubber flaps are provided at rear end of the wheels.
- The lighting arrangement of trailer is not provided as per IS 8213:2020. This should be looked into for corrective action.
- The specification of trailer does not conform in full, to the IS 8213:2020. This should be looked into for corrective action.
- 12.5 The dimensions of hydraulic tipping cylinder do not meet, in full to the requirement of IS 12371:2019. This should be taken care for corrective action
- The dimensions of ring type hitch does not meet, in full, the requirement of IS 11270:1980 (Reaffirmed 2019). This should be taken care for corrective action.
- The dimensions of various components of axle assembly do not conform, in full, the requirement of IS 8213:2000. This should be looked into for corrective action.
- 12.8 The Slow moving emblem & T sign is not provided. This may be provided
- 12.9 An axle assemble is not designed by its class and wheel track. This should be looked into corrective action.
