12. SUMMARY OF OBSERVATIONS, COMMENTS AND RECOMMENDATION

- 12.1 Dimensional requirements of single axle (semi trailer) conform to IS 8213:2020.
- 12.2 To protect from mud and soil the rubber flaps are provided at rear end of the wheels.
- 12.3 The lighting arrangement of trailer is not provided. This should be provided as per the requirement of IS 8213:2020.
- 12.4 The specification of trailer does not conform in full, to the IS 8213:2020. This should be looked into for corrective action.
- 12.5 The dimensions of hydraulic tipping cylinder do not meet, in full to the requirement of IS 12371:2019. This should be taken care for corrective action
- 12.6 The braking arrangement of trailer is not provided. This should be provided as per the requirement of IS 10806:2003.
- 12.7 The dimensions of ring type hitch does not meet, in full, the requirement of IS 11270:1980 (Reaffirmed 2019). This should be taken care for corrective action.
- 12.8 The dimensions of various components of axle assembly do not conform, in full, the requirement of IS 8213:2000. This should be looked into for corrective action.
- 12.9 The Slow moving emblem/ T sign are not provided. However, this should be as per the requirement of IS.
- 12.10 An axle assemble is not designed by its class and wheel track. This should be looked into corrective action.

12.10 Adequacy of literature:

Service manual parts catalogs of trailer were provided form which is not adequate. However, operation manual and parts catalogue be brought out in Hindi and other regional languages in **booklet form** as per IS 8132: 1999 (Reaffirmed 2019) for the sake of user & technical personnel.
