### 10 SUMMARY OF OBSERVATIONS, COMMENTS AND RECOMMENDATIONS

- 10.1 The specifications of plough share does not conform fully to the requirements of IS: 10691- 1983. It should be looked into for corrective action.
- The specification of implement hitch does not conform fully to the IS: 4468 (Pt-I)-1997. It is recommended that the same should be provided conforming to the relevant Indian Standards.
- 10.3 The chemical composition of bar point does not meet, in full, the requirement of IS: 10691-1983. This should be looked into for corrective action.
- The hardness of share and bar point does not meet, in full, the requirement of IS: 10691-1983. This should be looked into for corrective action.

### 10:5 Adequacy of literature:

The Operating, Instruction, Maintenance manual and parts catalogue was supplied with the mould board plough for reference during the testing in English. It is however, recommended that same may be revised as per IS: 8132-1999.
