- To protect from mud and soil the rubber flaps are provided at rear end of the 12.1
- The lighting arrangement of trailer is not provided as per IS 8213:2020. This 12.2 should be looked into for corrective action. 12.3
- The specification of trailer does not conform in full, to the IS 8213:2020. This should be looked into for corrective action.
- The dimensions of hydraulic tipping cylinder does not meet, in full to the 12.4 requirement of IS 12371:2019. This should be taken care for corrective 12.5
- The dimensions of ring type hitch does not meet, in full, the requirement of IS 11270:1980 (Reaffirmed 2019). This should be taken care for corrective
- The dimensions of various components of axle assembly do not conform, in 12.6 full, the requirement of IS 8213:2000. This should be looked into for corrective action.
- The Slow moving emblem & T sign are not provided. This may be provided 12.7 12.8
- An axle assemble is not designed by its class and wheel track. This should \ 'be looked into corrective action.
