- The amplitude of mechanical vibration on various assemblies of the Pove Reaper was observed to the extent of 391 micron, which is on higher side. Therefore necessary action to reduce the vibration should be taken future.
- The dimension of Knife does not conform, in full, to IS: 6025-1982.
- 15.3 Provided labeling plate should be as per the requirement of IS.

15.4 Wear of critical components:

- i) The wear rate of cutter bar on mass basis was recorded as 0.023 % phour.
