

**7. COMMENTS & RECOMMENDATIONS**

- 7.1 The hardness of blade for Power tiller at hardened zone conforms to IS 6690:1981.
- 7.2 The chemical composition of blade for Power tiller is conforming except the Carbon of the relevant code (IS 6690:1981) & therefore it should be looked into for the corrective action.
- 7.3 The blade is not labeled with trade mark name, max. recommended rpm, and code number. However, blade should be marked with type & thickness also.
- 7.4 **Adequacy of literature supplied with the component:**

A single page print of blade figure along with its application is provided for reference with the component. Hence, it is recommended to brought out as per IS 6690:1981 for the sake of user & technical personnel.
