### 12. SUMMARY OF OBSERVATIONS, COMMENTS AND RECOMMENDATION

- 12.1 The specification of trailer does not conform, in full, to the IS 8213:2000 (Reaffirmed 2020). This should be looked into for corrective action.
- 12.2 Lighting arrangement for trailer is not provided as per IS 8213:2000 (Reaffirmed 2020). This should be taken care for corrective action.
- The dimensions of hydraulic tipping cylinder do not meet, in full, to the requirement of IS 12371:1988 (Reaffirmed 2019). This should be taken care for corrective action.
- The dimensions of ring type hitch does not meet, in full, the requirement of IS 11270:1985 (Reaffirmed 2019). This should be taken care for corrective action.
- The dimension of various components of axle assembly does not confirm, in full, the requirement of IS 8213:2000 (Reaffirmed 2020). This should be taken care for corrective action.
- 12.6 Adequacy of literature:

Service manual and parts catalogue of trailer were not provided in booklet form. Operation manual and parts catalogue should be brought out in Hindi and regional languages as per IS 8213:2000 (Reaffirmed 2020) for the sake of user & technical personnel.
