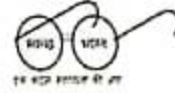

1. Age Limit : Between 18-27 years (relax able for government servants up to forty years in accordance with the instructions or orders issued by the Central Government from time to time).  
**Note:** The crucial date for determining the age limit shall be the closing date for receipt of applications
2. Educational Qualifications : i) Industrial Training Institute (ITI) Certificate in Electrical Trade or Diesel Mechanic Trade or Tractor Mechanic Trade with Three years experience in any of the trades mentioned above and proficiency in driving and maintenance of vehicles and tractors and should possess a valid Driving License for light and Heavy Duty Vehicles and Tractors; or
