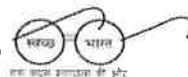

3. Tenders will be opened on the same day i.e. 04.10.2017 at 3.00 pm. in the committee Room of Admin Block.
4. Every tenderer will have to deposit **Rs.1000/-** as EMD, either in cash/DD in favour of **Director, S.R.F.M.T.&T.I, Garladinne, Anantapur (A.P.)**, Payable at SBI, Sai Nagar, Branch Code No. 0806, Anantapur, for participating in the tender auction.

TERMS AND CONDITIONS FOR TENDER AUCTION

1	Tender must be submitted in the prescribed tender form obtainable from the office of S.R.F.M.T.T.I., Tractor Nagar, Garladinne on any working day from 10 Am to 5 PM from 19.09.17 to 04.10.2017 (up to 1 Pm on 04.10.2017)
2	(i) Every tenderer must deposit Rs. 1000/- as EMD to participate in tender auction either in cash or Demand Draft in favour of The Director S.R.F.M.T.T.I. , Garladinne (A.P.) payable at State Bank Of India, Sai Nagar Branch, Code 0806, Anantapur (A.P.) . The tender will not be considered if the earnest money is not deposited along with tender. Date of Demand Draft should be drawn after the issue of the advertisement clearly indicated in the form. (ii) The tenderer / bidder should append his signature on the tender form, without which the bid is liable to be rejected. (xix) The demand draft of EMD and the demand draft of cost of tender form should be separate, if tender form is downloaded from the Institute's website. : www.srfmtti.dacnet.nic.in The cost of tender form is Rs. 50.00.
3	Tenderer may see/inspect the condition of the farm orchard in any working days (Mon-Fri) between 9.00 AM to 5.00 PM with the permission of Farm In- charge/nominated technical officer by the concerned In- charge.
4	The tenderer should furnish his full name and address on the tender form.
5	Tenderer should submit tender form in a sealed cover, marked " Tender for Purchase of Lemon ". The tender will also be accepted by Registered Post before due date i.e. 04.10.2017 (01:00 PM) . Institute will not be responsible for any postal delay or delay due to any reasons.
6	Last date and time for receipt of tender form is 04.10.2017 at 01:00 PM
7	Date and Time of opening of tender will be 04.10.2017 at 03:00 PM. , in the committee room of Administrative Block at S.R.F.M.T.T.I. Garladinne.
8	OPENING OF TENDER: Bidders/tenderers are at liberty to be present himself/ themselves or authorize a representative to be present at the time of bid/opening of tender.
9	In case of Lemon fruit crop, 25% of bid amount has to be deposited by successful bidder on the spot and rest of 75% of bid amounts is to be paid by Demand Draft/Cash by 25.10.2017 or before start plucking of orchard fruits, whichever is earlier.
10	It to clarify that under any circumstances plucking / harvesting/ collecting will not be allowed unless full amount of bid is deposited in the office . If the full amount of the bid is not deposit within stipulates time, all the deposited amount i.e. EMD and the amount deposit on the spot will stand forfeited and they would be deposited with the Govt. Account.
11	The successful bidder should not sub-lease the tender and in the event of this office coming to know about the sub-leasing of the tender, the entire amount shall stand forfeited.
12	The tenderers shall harvest/pluck/collect the fruits of said orchards only on working days (Mon to Fri) from 9.00 AM to 5.00 PM .

13	The tenderers shall have no objection for the official of this Institute to carry out the farm operation/ field operations and inspection.
14	EMD received from unsuccessful bidders will be returned immediately after the process of bid/auction is completed.
15	The Institute will not be responsible for any kind of theft / damage / losses to the tendered produce. However if any damage occurs to the properties of the institute by the bidder/tenderer or his representative or his labour, appropriate action will liable to be initiated against tenderer.
16	Fruit crop will be allowed to be plucked/harvest/collected from the Orchards/Farm, under the supervision of Farm In charge/supervisor during working days.
17	No child labour shall be engaged or caused to be engaged by bidder.
18	SECURITY DEPOSIT: A. For Orchard fruit crops: Tenderer has to deposit 10% of the bid price as a security amount on the spot. B. The security deposit amount will be refundable after successful completion of tender period/tenure please note that tenderer will be required to provide duly filled of <u>MANDATE FORM</u> for depositing the amount in directly in the bank.
