TERMS & CONDITIONS

1. Tender fee is Non-refundable and Tender is non-transferable.
2. Any offer valid for a period of less than 30 days will be liable to be ignored.
3. State sales Tax as legally liveable will have to be paid extra by the Tenderer to the concerned Sales Tax Authorities. Certificate of exemption of Sales Tax if any will have to be produced by the Tenderer.
4. Tenderers are required to furnish D.Ds separately for Rs. 10,000/- as EMD and successful bidders shall submit security deposit Rs. 8000/- immediately.
5. **Highest Tender not necessary to be accepted.** The Director of the Institute is not bound to accept the highest or any tender or to assign any reason for non-acceptance. Price offered will be considered only in the Tender form issued by the office.
6. **DELIVERY OF TENDER :-**
 - (I) This Tender is to be delivered in prescribed form in double sealed cover put together in a larger sealed envelope with clear superscription on each cover for identification purpose as shown on page 2.
 - (II) The Director will not accept any request for extension of Tender due date for late receipt of Tender forms or any other reasons and is not responsible for any missing/late/damage delivery of the Tender sent by post and no correspondence in the said connection will be entertained.
 - (III) Sealing must be done with sealing wax. Unsealed Tender will be treated invalid.
7. **PRICES :-**

Prices must be rounded to nearest rupee and quoted in English, both in words and figures per unit (on item/weight basis) shown in the schedule in case of any discrepancy, the units and rates written in words shall prevail.
8. **EARNEST MONEY AND SECURITY DEPOSIT :-**

This tender must be accompanied by the Demand Draft drawn in favour of The Director, SRFMT&TI, Garladinne on State Bank of India (Branch code: 0806) payable at Anantapur for the amount specified. The Tenderer shall hold the offer open till such date as may be specified in the Tender. It is understood that the Tender document has been sold to the Tenderer and the Tenderer is being permitted to Tender in consideration of the stipulation on his part that after submitting his tender, he will not resile from his offer or modify the terms and conditions thereof in a matter not acceptable to the Director of the Institute. If after issue of the Sale letter, the Tenderer refuses to accept stores already decided in his favour, within the time specified in the sale letter, the Government will have full right to cancel the Tender and forfeit the security deposit and refund earnest money only.

8-A:- On due performance of the contract and on submission of no demand certificate, the security deposit will be returned to the successful Tenderer provided always that no claim shall lie against the Government in respect of the interest thereof nor for any loss or depreciation thereof while in the custody of the Government.

8-B:- No interest will be liable to be payable on Earnest money/Security deposit amount lying with the Institute for refund.
9. **TENDER TO BE SIGNED AND COMPLETED :-**
 - (I) This tender must be signed and witnessed in the case of a partnership should sign or someone holding a power of Attorney. Disregard of these instructions or if the tender is in any way incomplete is liable to be ignored.
 - (II) All corrections and over writings should be attested and dated by the

Tenderer/Buyer in ink under full signature.

10. CONDITION OF STORES :-

The store is sold as it lie and shall be removed by the Buyer with all faults and not withstanding any error.

11. RISK :-

The stores shall remain in every respect at risk of Buyer from the date of acceptance of his offer by the director and Govt. shall not be under any liability for the safe custody or preservation.

12. MODE OF PAYMENT :-

The successful Tenderer has to deposit the entire amount of the tendered amount or should at least deposit not less than 25% of the tendered amount at the first instance after finalization of tender. The balance amount should be deposited within 12 days in the office from the date of issue of sale letter in the form of Demand Draft drawn in favour of Director, SRFMT&TI, Garladinne payable at Sate Bank of India Anantapur (Branch code: 0806) payable at Anantapur. If he fails to deposit the balance amount as stipulated the 25% of the total tendered amount deposited by the Tenderer is liable to be forfeited as such and credited to Government accounts and no request will be entertained thereafter whatsoever.

13. CORRUPT PRACTICES :-

Any bribe, commission, gifts or advantage given, promised or offered by or any one on behalf of the Buyer or his partner, agents or servant or any on his or their behalf (whether with or without the knowledge of the Buyer) to any officer, servant, representative or agent of Govt. in relation to the obtaining or to the execution of this contract with the Govt., shall in addition to any criminal liability which he may incur subject the Buyer to the cancellation of this and all other contracts and also to payment to Government of any loss resulting from any such cancellation.

14. ASSIGNMENT OR SUB-LETTING OF CONTRACT :-

All disputes and differences arising out of sale shall be referred to the sole arbitration to any officer in the Ministry of Law appointed as the Arbitrator by the Director of the Institute.

15. PRODUCTION OF VALID INCOME TAX CLEARANCE CERTIFICATE :-

Every Tenderer should furnish valid income tax clearance certificate or Photostat copies thereof, from the Income Tax Officer indicating that the Tenderer is assessor of his ward and his Permanent Account Number if already allotted.

16. ELIGIBILITY OF TENDERERS :-

No minor will be eligible to tender.

17. POWER TO REJECT THE TENDER :-

The Director of the Institute reserve the right to reject all or any tender without assigning any reasons whatsoever.

18. The Institute is under the provision of RTI Act 2005. All the information provided by you under the act is liable to be disclosed.

19. The tenderers should submit their address proof with tender form either in the form of voter ID card/aadhar card/ration card/driving license/ Telephone Bill or Electric Bill.

20. Under any circumstances, the right of adjudication shall rest with The Director, S.R.F.M.T&T.I., Garladinne – 515 731 and his decision will be ultimate and binding on all parts.
