

- 04. Every tenderer will have to deposit EMD as mentioned above in the table for participating in the tender auction.
- 05. For MANGO orchard, 25% of bid amount(by Bharathkosh) and 10% of the bid price as a security amount (by Bharakosh) has to be deposited by successful bidder on the spot (27.03.2024) and rest 75% of bid amounts is to be paid by 26.04.2024 or before start plucking of orchard fruits, whichever is earlier.
