9. EASE OF OPERATION & ADJUSTMENTS

No difficulty was observed during the operation and adjustment of Trailer.

10. DEFECTS, BREAKDOWNS AND REPAIRS

No defect/breakdown and repair was occurred during entire period of testing.

11. SUMMARY OF OBSERVATIONS, COMMENTS AND RECOMMENDATION

- 11.1 To protect from mud and soil the rubber flaps are provided at rear end of the wheels.
- 11.2 Dimensional requirements of single axle (semitrailer) conform to IS 8213:2000.
- 11.3 Lighting arrangement except slow moving vehicle emblem of trailer is provided as per IS 8213:2000.
- 11.4 The specification of trailer does not conform in full, to the IS 8213:2000. This should be looked into for corrective action.
- 11.5 The dimensions of hydraulic tipping cylinder does not meet, in full to the requirement of IS 12371:1988. This should be taken into for corrective action
- The dimensions of ring does not meet, in full, the requirement of IS 11270:1980 (Reaffirmed 1999). This should be taken into for corrective action.
- 11.7 The dimensions of various components of axle assembly do not conform, in full, the requirement of IS 8213:2000. This should be taken into for corrective action.
- 11.8 Labeling plate should be provided as per the requirement of IS.
