

9. EASE OF OPERATION & ADJUSTMENTS

No noticeable difficulty was observed during the operation and adjustment of Multi crop thresher.

10. DEFECTS, BREAKDOWNS AND REPAIRS

No defect/breakdown was occurred during entire period of field & lab tests.

11. COMMENTS & RECOMMENDATIONS

- 11.1 The material of construction of different components of thresher is conforming as per IS 6284 : 1985
- Provision for different adjustments on thresher is provided as per IS 6284:1985.
- 11.3 Most of the parameters are meeting the requirement of IS 9020:2002.
- The specification of feeding chute does not conform to IS: 9020-2002 (Reaffirmed 2012). This should be looked into.
- Standard PIC & its yoke bore for 6-splined is not as per IS 4931 : 1995 should be provided.
- The labeling plate should be provided as per the requirements of IS.
