

# 11. SUMMARY OF OBSERVATIONS, COMMENTS AND RECOMMENDATIONS

- 11.1 The specifications of plough share does not conform fully to the requirements of IS: 10691- 1983. It should be looked into for corrective action.
- The specification of implement hitch does not conform fully to the IS: 4468 (Pt-I)-1997. It is recommended that the same should be provided conforming to the relevant Indian Standards.

### 11.3 Hardness & Chemical Analysis:

The hardness & chemical composition of share and bar point does not meet, in full, the requirement of IS: 10691-1983. This should be looked into for corrective action.

### 11.4 Marking/labeling:

The labeling plate does not reveal all the required information. It is therefore recommended that a suitable labeling plate covering all essential components, interlaid, the following must be provided:

- I. Size of implement
- II. Type
- III. Country of origin
- IV. Batch or code number
- V. Country of origin
- VI. Weight, (kg)

### 11.5 Adequacy of literature:

User's manual is not provided during the test. However, the same must be brought out in Hindi & other regional languages as per IS 8132:1999 (Reaffirmed 2004) for the guidance of users.

The following literature should be provided.

- i) Service manual
- ii) Parts catalogue
