17.3 Components/assembly inspection:

- **17.3.1** The transplanter and engine were dismantled 41.67hours of operation, respectively and wear of critical components were observed within the limits.
- 17.3.2 The main gear box, planting box, planting arm drive mechanism and bearings were dismantled after completion of field operation and found in satisfactory working condition.

## 17.4 Safety provisions:

The machine is provided with various safety provisions while working in the field or moving on the road as mentioned in the **clause 5.16** of this test report.

17.5 The notations for all controls, Instrument panel, labeling plate and safety provisions are written on the machine in English language. This should be looked into for sake of Indian farmers/users.

### 17.6 Technical literature:

Operator's manual, technical manual and parts catalogue of Rice Transplanter and engine in separate booklet were supplied with the Rice Transplanter for reference during the test.
