#### 17. COMMENTS & RECOMMENDATIONS

- 17.1 The rated power was observed as 1.21 kW under natural ambient condition against the declared value of 1.20 kW.
- 17.2 The safety provisions, as mentioned at Para 5.14, have been provided by the applicant for safety aspect of operators.
- 17.3 A fuel on/off knob may be considered for providing in the fuel system of engine.

#### 17.4 **Noise measurement:**

Max. Noise at operator's ear level was observed as 99 dB (A), which is on higher side, therefore suitable corrective action should be taken to reduce the noise level.

#### 17.5 Mechanical vibration:

The equivalent mechanical vibration on engine cover was observed to the extent of 217 micron. This should be looked into for dampening the vibration.

#### 17.6 Chemical analysis:

The chemical analysis of Straight blade (2 teeth) is not as per requirement of the relevant code IS 6025:1982 (Reaffirmed 1999) & therefore it should be looked into for the corrective action.

#### 17.8 Adequacy of literature supplied with the machine:

User's manual is not provided during the test. However, the same must be brought out in Hindi & other regional languages as per IS 8132:1999 (Reaffirmed 2004) for the guidance of users.

- ii) Parts catalogue
