### 17. COMMENTS & RECOMMENDATIONS

- 17.1 The rated power was observed as 0.90 kW under natural ambient condition against the declared value of 0.90 kW.
- 17.2 The safety provisions, as mentioned at **Para 5.14**, have been provided by the applicant for safety aspect of operators.
- 17.3 A fuel on/off knob may be considered for providing in the fuel system of engine.

### 17.4 Noise measurement:

Max. Noise at operator's ear level was observed as 109 dB (A), which is on higher side, therefore suitable corrective action should be taken to reduce the noise level.

### 17.5 Mechanical vibration:

The equivalent mechanical vibration on engine cover was observed to the extent of 364 micron. This should be looked into for dampening the vibration.

### 17.6 Hardness and Chemical analysis:

The Hardness and chemical analysis of straight blade (2Teeth) is not as per requirement of the relevant code IS 6025:1982 (Reaffirmed 1999) & therefore it should be looked into for the corrective action.

### 17.7 Marking /labeling:

The labeling plate does not reveal all the required information. It is therefore recommended that a suitable labeling plate covering all essential components, interlaid, the following must be provided:

- i) Address of the applicant
- ii) Country of origin
- iii) Make
- iv) HP
- v) Rated rpm
- vi) Specific fuel consumption, (g/kWh)

### 17.8 Adequacy of literature supplied with the machine:

User's manual is not provided during the test. However, the same must be brought out in Hindi & other regional languages as per IS 8132:1999 (Reaffirmed 2004) for the guidance of users.

The following literature should be provided.

- i) Service manual
- ii) Parts catalogue
