**ORDER**

Whereas a case against Shri Uggersen, MTS(T) was registered by Station House Officer, Singanamala Police Station, Anantapur u/s 354(a), 506 of IPC & Section 7& 8 of POCSO Act, 2012 vide F.I.R. No. 88/2023 dated 22/06/2023 and he was taken into custody by the Singanamala Police on 23.06.2023.

And whereas, Shri Uggersen, MTS(T) was placed under suspension by the competent authority in exercise of the powers conferred by sub-rule (1)(b) of Rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965.

And whereas, Shri Uggersen, MTS(T) has been released on bail vide order dated 31.07.2023 of the Special Court, designated for speedy trial of offences under the Protection of Children from Sexual Offences (POCSO) Act, 2012, Ananthapuramu under Criminal Miscellaneous Petition No. 554 of 2023.

And whereas, the suspension of Shri Uggersen, MTS(T) was reviewed in context of the aforementioned order of the Special Court and the conditions laid down there and it is observed that there appears no reason to continue the suspension of Shri Uggersen, MTS(T).

Now, therefore the undersigned in exercise of the powers conferred by Sub-rule 5(c) & 6 of Rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, hereby revoke the suspension of Shri Uggersen, MTS(T) with effect from 15.09.2023 pending the adjudication of the Hon'ble Court in the aforementioned case. Shri Uggersen, MTS(T) shall abide by the conditions of the bail and the conduct rules.
