# MINISTRY OF AGRICULTURE AND FARMERS WELFARE (Department of Agriculture and Farmers Welfare)

#### NOTIFICATION

- G.S.R....... (E). In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Agriculture and Farmers Welfare, Department of Agriculture, Cooperation and Farmers Welfare, Farm Machinery Training and Testing Institute (Group 'A' and Group 'B' Official Language posts) Recruitment Rules, 2017 except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the Group 'A' and Group 'B' posts relating to Official Languages in the Ministry of Agriculture and Farmers Welfare, Department of Agriculture and Farmers Welfare, in the Farm Machinery Training and Testing Institutes, namely:-
- 1. **Short title and commencement.** (1) These rules may be called the Ministry of Agriculture and Farmers Welfare, Department of Agriculture and Farmers Welfare, Farm Machinery Training and Testing Institute(Group 'A' and Group 'B' Official Language posts)Recruitment Rules, 2024.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Application.** These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and level in the pay matrix. The number of thesaid posts, their classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the aforesaid Schedule.
- 4. **Method of recruitment, age-limit, qualifications, etc.** The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 5. **Disqualification.** No person-
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. **Power to relax.** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard

Recognised Diploma or Certificate course in translation from Hindi to English and vice versa or two year's experience of translation work from Hindi to English and vice versa in Central or State Government Office, including Government of India Undertakings.

Note 1:Qualifications are relaxable at the discretion of the Staff Selection Commission for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

Note 2:The qualifications regarding experience are relaxable at the discretion of the Staff Selection Commission for reasons to be recorded in writing, in case of candidates belonging to Scheduled Castes or Scheduled Tribes if at any stage of selection, the Staff Selection Commission is of the opinion that sufficient number of candi9dates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

#### Promotion

Junior Translation Officer in level-6(Rs.35400-112400) in the pay matrix with ten years' regular service in the level.

**Note:** Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying or eligibility service.

### Deputation(including short term contract):

Officers from the Central or State Governments or Union territories or Public Sector Undertakings or Universities or Recognised Research Institutions or Statutory and Autonomous bodies:

(a)(i)holding analogous posts on regular basis in the parent cadre or department; or

(ii) with two years' service in the level rendered after appointment thereto on regular basis in posts in 8(Rs.47600-151100) in the pay matrix or equivalent in the parent cadre or department; or

(iii)with three years' service in the level rendered after appointment thereto on regular basis in posts in level-7(Rs.44900-142400) in the pay matrix; and

(b) possessing the following educational qualifications and experience, namely:-

(i) Master's degree of a recognised University in Hindi with English as a compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognised University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level:

Or

Master's degree of a recognised University in any subject other than Hindi or English, with Hindi medium and English as a compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognised University in any subject other than Hindi or English, with Hindi and English as compulsory or elective subject or as the medium of examination at the degree level;

Or

Master's degree of a recognised University in any subject other than Hindi or English, with Hindi and English as compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level.

(ii)Three years 'experience of using or applying terminology(terminological work) in Hindi and translation work from English to Hindi or vice-versa, preferably of technical or scientific literature under Central or State Governments or Autonomous Bodies or Statutory organisations or Public Sector Undertakings or Universities or recognised research or educational institutions;

Or

Three years' experience of teaching in Hindi and English or research in Hindi or English under Central or State Governments or Autonomous Body or Statutory organisations or Public Service Undertakings or Universities or recognised research or educational institutions.

## Desirable:

Studied one of the languages other than Hindi included in the Eighth Schedule to the Constitution at 10<sup>th</sup> level from a recognised board.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall be not eligible for consideration for appointment by promotion.

(Period of deputation(including short term contract) in another ex-cadre post held immediately preceding this

appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years. The maximum age-limit for appointment by deputation(including short term contract) shall be not exceeding fifty six years as on the closing date of receipt of applications).
