TERMS AND CONDITIONS FOR TENDER DRUMSTICK ORCHARD Tenders must be submitted in the prescribed tender form, which can be obtained from the office of S.R.F.M.T.T.I., Tractor Nagar, Garladinne, on any working day between 10:00 A.M. to 5:00 P.M., from 05.08.2025 to 21.08.2025 (up to 11:00 A.M. on 21.08.2025). (i) Every tenderer must deposit an Earnest Money Deposit (E.M.D.) of Rs 2,000 in the form of a Demand Draft drawn in favour of DIRECTOR, Southern Region Farm Machinery Training and Testing Institute, payable at State Bank of India located at Sainagar Branch, Anantapur. The IFSC code is SBIN0000806. Or through Bharatkosh (http://bharatkosh.gov.in) to Tenders submitted without the E.M.D. will not be considered. Tenders may also be submitted via Registered Post, provided they are received before the due date, i.e., 21.08.2025 by 11:00 A.M. The Institute shall not be held responsible for any delays caused by postal services or any other unforeseen circumstances. 6 The tender form must be submitted no later than 21.08.2025 by 11:00 A.M. The tender will be opened on 21.08.2025 at 11:00 A.M. in the Committee Room of the Administrative Block at S.R.F.M.T.T.I., Garladinne. Opening of Tender: Bidders/tenderers are welcome to be present in person or may authorize a 8 representative to attend the tender opening on their behalf. For the Drumstick fruit crop, the successful bidder is required to deposit 25% of the bid amount on the spot on 21.08.2025. Any such activities, if found to be carried out, will attract legal action as per applicable rules and regulations. 	clearly understood that bidders have no right to object to or interfere with the routine farm

21	The Institute shall not be held responsible for any loss of crops resulting from natural disasters. In the

23	The bidder shall not engage , nor permit the engagement of child labour under any circumstances, in
	strict compliance with applicable labour laws and regulations.
24	Security Deposit:
	(A). For the Drumstick orchard fruit crop, the tenderer is required to deposit 10% of the bid amount as
	a security deposit through Bharatkosh on the spot, i.e., on 21.08.2025.
	(B). The security deposit will be refunded upon successful completion of the tender . To facilitate the
	refund through direct bank transfer, the tenderer must submit their bank account details along with a
