Sealed tenders are hereby invited from interested individuals, farmers, Farmer Producer Organizations (FPOs), Self-Help Groups (SHGs), vendors, co-operative societies, firms, companies and other eligible entities for the auction of the following farm produce on an "as-is-where-is" basis :

01. The tender form, along with the terms and conditions, can be obtained from the office on working days only (Monday to Friday). Issuance of tender forms will commence on **31.03.2026**. The closing date and time for the receipt of completed tenders is **09.04.2026, up to 11:00 a.m.**

02. The tender form is on **free of cost** and can also be **downloaded** from the Institute's website: **<http://srfmtti.dacnet.nic>**.

03. Tenders will be opened on the same day, i.e., **09.04.2026, at 11:00 a.m.** in the Committee Room of the Administrative Block.

04. Each tenderer must deposit the Earnest Money Deposit (EMD), through DD / webportal **<http://bharatkosh.gov.in>**, as specified in the table above, in order to participate in the tender auction.

05. The successful bidder shall lift the entire quantity of Redgram grains in one lot within 7 days from the date of award of the tender or as directed by the Institute; however, lifting of the produce shall not be permitted unless the full payment has been made.

06. **Full payment (100%)** of the bid amount for Redgram must be made on the spot or **within 7 days of acceptance of the bid whichever is earlier**, through the Bharatkosh portal, before lifting the material.

07. Any loss or damage to the produce after the award of tender shall be the responsibility of the successful bidder.

08. The successful bidder shall be responsible for collection, and lifting transportation of the produce at their own cost and risk. The Institute will not provide any labour and transport or equipment.

09. Interested tenderers may visit to see the produce **on any working day (Monday to Friday)** between 9:00 a.m. and 5:00 p.m.

10. If the tendered rates for the above-mentioned redgram grains is found to be lower than the reserve price (Rs.80/-per KG) fixed by the Farm Produce Disposal Committee (FPDC), they will not be accepted.

11. Tenderers must submit **proof of address** along with the tender form, which may include a bank account passbook photocopy, Voter ID card, Aadhaar card, ration card, driving license, telephone bill, or electricity bill.

12. The Director of the Institute **reserves the right** to reject any or all tenders, either fully or partially, at any time without assigning any reason.

TERMS AND CONDITIONS FOR TENDER – REDGRAM GRAINS

1	Tenders must be submitted in the prescribed tender form, obtainable from the office of S.R.F.M.T.T.I., Tractor Nagar, Garladinne , on any working day (Monday to Friday) between 10:00 A.M. and 5:00 P.M. , from 31.03.2026 to 09.04.2026 (up to 11:00 A.M.) .
2	Earnest Money Deposit (EMD): (i) Every tenderer must deposit an EMD of Rs. 4,000/- in the form of a Demand Draft drawn in favour of Director, SRFMTTI , payable at State Bank of India, Sainagar Branch, Anantapur (IFSC: SBIN0000806) or through Bharatkosh (http://bharatkosh.gov.in) . (ii) Tenders submitted without EMD will be summarily rejected. (iii) The EMD of unsuccessful bidders will be refunded after completion of the tender process. (iv) The tender form must be duly signed; unsigned tenders are liable to be rejected. (v) The tender form can also be downloaded from www.srfmtti.dacnet.nic.in and is free of cost .
3	Tenderers may inspect the produce on any working day between 9:00 A.M. and 5:00 P.M. with prior permission from the Farm In-charge or authorized officer.
4	The tenderer must furnish full name, address and valid identity proof along with the tender form.
5	The tender shall be submitted in a sealed envelope superscribed as: “Tender for Purchase of Redgram Grains” . It may also be sent by Registered Post, ensuring delivery before 09.04.2026 up to 11:00 A.M. The Institute is not responsible for postal delays.
6	The last date for submission of tender is 09.04.2026 up to 11:00 A.M.
7	The tender will be opened on 09.04.2026 at 11:00 A.M. in the Committee Room of the Administrative Block, SRFMTTI, Garladinne.
8	Opening of Tender: Tenderers or their authorized representatives may be present at the time of opening of tenders.
9	Payment Terms: Full payment (100%) of the bid amount for Redgram must be made on the spot or within 7 days of acceptance of the bid whichever is earlier , through the Bharatkosh portal, before lifting the material.
10	No lifting of Redgram grains shall be permitted unless the full payment is made . Failure to make payment within the stipulated period will result in forfeiture of EMD and any deposited amount .
11	The quantity of Redgram (302 Kgs approx.) is indicative and may vary slightly. No claim shall be entertained on this account.
12	The successful bidder shall lift the entire stock within 7 days after completion of tender process , during working hours (9:00 A.M. to 5:00 P.M., Monday to Friday).
13	Partial lifting is not permitted. The entire quantity must be lifted in one lot.
14	The bidder shall maintain proper conduct and ensure no damage to Institute property. Any loss/damage shall be recovered from the bidder.
15	The Institute shall not be responsible for any theft, loss, or damage to the produce after award of the tender.
16	In case of failure to lift the stock within the stipulated time, the Institute reserves the right to cancel the allotment, forfeit deposits, and re-tender at the risk and cost of the bidder .
17	Tenderers shall be permitted to lifting and collecting grains only on working days after completion of tender process in two days between (Monday to Friday) and strictly between 9:00 A.M. and 5:00 P.M.
18	The Earnest Money Deposit (EMD) submitted by unsuccessful bidders shall be refunded promptly upon completion of the bidding/auction process .
19	The redgram grains collecting and lifting grains material farm only under the supervision of the Farm In-charge or Supervisor and strictly on designated working days .
20	The bidder shall not engage, nor permit the engagement of child labour under any circumstances, in strict compliance with applicable labour laws and regulations.
21	The Director, SRFMTTI, Garladinne reserves the right to accept or reject any or all tenders without assigning any reason, and the decision shall be final and binding.
