- The sale of scrap materials is strictly on an "AS IS WHERE IS" and LOT-WISE basis. The bidder is deemed to have inspected the materials and understood their quality, quantity and location before bidding.
- 2. Tenders must be submitted in the prescribed tender form, which can be obtained from the office of S.R.F.M.T.T.I., Tractor Nagar, Garladinne, on any working day between 10:00 A.M. to 5:00 P.M., from 02.12.2025 to 23.12.2025 (up to 11:00 A.M. on 23.12.2025).
- (i) Every tenderer must deposit an Earnest Money Deposit (E.M.D.) of Rs.10,000/- in the form of a Bharatkosh / Demand Draft. DD drawn in favour of **DIRECTOR**, **Southern Region Farm Machinery Training and Testing Institute**, payable at **State Bank of India located at Sainagar Branch**, (IFSC code: **SBIN0000806**) **Anantapur**. Or through Bharatkosh (http://bharatkosh.gov.in). Tenders submitted without the E.M.D. will not be considered. The E.M.D. amount will be refunded to unsuccessful bidders after completion of the due procedure.
 - (ii) The tenderer/bidder must sign the tender form. Unsigned bids are liable to be rejected.

- The Institute makes **no guarantee or warranty** as to the quantity, quality, size, fitness, or merchantability of the materials in any lot. The description of lots and estimated quantities provided by the Institute are purely **indicative and approximate**. No claim, dispute, or compensation will be entertained on account of any variation in description, quantity, or quality.
- No sorting, segregation, or 'pick-and-choose' of items within a lot will be permitted at the time of lifting/delivery. The successful bidder must lift the entire lot as offered.
- 7 <u>Eligibility of Bidders & Required Documents</u>: The tender is open to all registered firms/individuals/scrap dealers dealing in the purchase and disposal of such materials.
- For Hazardous/Environmentally Sensitive Materials (Batteries mentioned at Lot 4), Tyres and plastic materials (Mentioned at Lot 5 & 6), the bidders must submit a valid and existing RVSF, registration / authorization certificate from the Central Pollution Control Board (CPCB) or the respective State Pollution Control Board (SPCB) for handling and processing the specific waste types, <u>as applicable</u>. Failure to submit valid documents for relevant lots will lead to rejection of the bid for that lot.
- 9 Bidders must submit copies of: PAN Card, GST Certificate and KYC documents of the firm/authorized representative as per requirement.
- 10 Submission of Tender: Tenders must be submitted in a sealed envelope clearly super-scribed with "Tender for Sale of Scrap Materials Lot [Lot Number(s)]" and addressed to the designated authority.
